Directions: Take U.S.Rt.60 south through Duncan Falls, cross bridge Turn left (east) onto CUTLER LAKE RD. Stay on two miles Turn Left onto MOCK RD., follow to stop sign, Turn Right onto SUGAR GROVE RD. Go up over the hill and gate to range is on the Right.

Rifles: NRA service rifle rules section 3.1, 3.1.1, 3.1.2 & 3.1.3. Basically M-1903, M1 Garand, Johnson, M-14 (M1-A) and M-16 (AR15). No external modifications to stock & barrel. Military iron sights but dimensions may vary of rear sight aperture & front sight blade. COMPETITORS MUST SUPPLY THEIR OWN RIFLE AND AMMUNITION.

Course of fire: 200 Yard SR 10x targets

3 spotter shots 3 minutes

Prone: 10 shots for score 10 minutes

Sitting: 10 shots for score 10 minutes

Kneeling: 10 shots for score 10 minutes

Standing: 10 shots for score 10 minutes

400 Point Total

If competitor cannot assume any position he can elect to fire in the next progressive position.

Disabled competitors enter in disabled class and can fire any position they can assume or seated in chair.

A complete set of rules and directions to range can be emailed or mailed upon receipt of entry form.

You Must Be A Member of the Marine Corps League, USMC, USMCR or USMC Ret. to participate.

Teams may enter as four man fire teams. Trophies will be given for Detachment Teams and Individuals
